
BUILDING ON OUR LEGACY:

For almost a century, the Chicago Urban League has strengthened the Chicago region by focusing on enhancing education, employment, and economic opportunity for African Americans. As one of the first and largest affiliates of the National Urban League in America, we are consistent leaders in the Urban League movement that started at the first wave of the Great Migration in 1916. In collaboration with our community partners, we serve as an incubator for improving personal obstacles, launching careers and businesses, and transforming lives in the Black community.



THE CHICAGO URBAN LEAGUE IN THE COMMUNITY

The Chicago Urban League has established itself as an influential force and passionate advocate for Chicago's African American community. Throughout the course of the year, the League has remained a prominent diversity thought leader, continuously working toward social progress through education, employment, and economic development. Following is a summary of how the League exemplified its mission and vision through its strategic initiatives in fiscal year 2016.



2015

JUNE

For the third year in a row, the Chicago Urban League, in partnership with United Airlines and the China-United States Exchange Foundation, sent a delegation of African American high school students on a two-week cross-cultural academic journey through China. During their trip they visited Beijing, Hangzhou and Shanghai.

JULY

The MetroBoard hosted a wine and beer happy hour fundraiser at Bar Louie. The event raised money for the annual Back-to-School Fest as well as general service initiatives spearheaded by the League.

SEPTEMBER

In September, the 2015 IMPACT Leadership Development Program began its second year at the League. IMPACT incorporates the personal, interpersonal and community development approaches for aspiring leaders. The program operates for nine months and culminates with a graduation celebration in May.



AUGUST

On Saturday, August 15, 2015, soaring temperatures and long lines did not stop families from attending the League's annual Back-to-School Fest. Attended by more than 1,400 participants, the attendance nearly doubled compared to the previous year. In preparation for the beginning of a new school year, the Fest celebrated students and motivated them to invest in their learning by providing them with a variety of fun activities, as well as backpacks filled with school supplies.

NOVEMBER

On November 7th at the Hilton Chicago, more than 1,500 business, civic, and elected leaders attended the League's 54th Annual Golden Fellowship Dinner (GFD). GFD raised more than \$1.7 million to support the education, economic empowerment, and social justice programs. "Inspiration for the Next Generation" was the theme for this year's dinner, emphasizing the League's goal to strengthen its connection with Chicago youth. The focus on young people was featured in a compelling video that debuted at GFD. The black-tie affair was hosted by Chicago comedian Damon Williams and included a rousing performance by Grammy® Award-winning entertainer and actress, Brandy. This year's Edwin C. "Bill" Berry Award was presented to two recipients; historian, activist, philanthropist and philosopher, Timuel Black and Pulitzer Prize winner and acclaimed author, Isabel Wilkerson. The award is named after Berry, who was the Chicago Urban League's President from 1956-1969 and a key leader. It is given annually to individuals who have made a mark locally and/or nationally through hard work, perseverance and creativity.



OCTOBER

The League partnered with Uber Chicago, and by late October, announced that it was more than halfway to its goal of hiring 10,000 new drivers from the south and west sides. "Chicago's economic future depends on more people having access to economic opportunity," Shari Runner, President and CEO of the Chicago Urban League said. "We're glad to see innovative new businesses like Uber are not just making lives easier through technology, but also empowering Chicagoans to earn money on their own time in their own neighborhoods."

DECEMBER

The “Truth and Justice for All: Advancing Police and Community Accountability Forum” examined the need for improved policing practices by the Chicago Police Department (CPD) following the death of Laquan McDonald. The Chicago Urban League brought together a panel of leading voices on social justice and legal issues for a critical discussion on how to reform the CPD and why reform is necessary. Community members had the opportunity to verbalize their growing frustrations and recommend ways to improve relations between their neighborhoods and the CPD.

2016



JANUARY

The Chicago Urban League appoints Shari Runner as permanent President and CEO. Runner, who had been serving as the Interim President and CEO, was appointed to the position permanently. Prior to her appointment as Interim President and CEO, Runner served as Senior Vice President for Strategy and Community Development since joining the organization in 2010. Before joining the League, Runner served as Vice President, First National Bank of Chicago, and earlier in her career worked for ABN/AMRO Bank leading overnight trading and the European Monetary System currency desks.

FEBRUARY

In celebration of Black History Month, the Chicago Urban League kicked off its fifth annual Black History Month Film Festival, "Journey through Black History: Connecting New and Past Generations." Three documentaries were shown that focused on racial stereotypes modern-day slavery, connection to the African Diaspora and activism. Each viewing was followed by a panel discussion with community thought leaders. Short films produced by four students in the League's Center for Student Development and Human Capital were also screened.



MARCH

In March 2016, the League released a study entitled *100 Years and Counting: The Impact of Racial Residential Segregation on Residence, Housing, and Transportation*. It dissects critical socioeconomic causal factors and outcomes related to enduring high levels of segregation in the city's most impoverished and segregated neighborhoods. Qualitative interviews and focus group data were gathered from issue-focused subject matter experts, including academics, activists/advocates, elected officials, human service providers, impacted persons and representatives from the business, nonprofit and philanthropic communities.

APRIL

The Chicago Urban League and the Red Pump Project, in partnership with the National Organization of Black County Officials hosted “Red Power Conversations.” Panel speakers were Darrious Hilmon, Dr. Eric Whitaker, Dr. Maya Green, and Erik Glenn.



MAY

On May 2, 2016, the Chicago Urban League presented its annual SUMMIT Luncheon themed “Blueprint for Change: From Ideas to Collective Impact.” The League recognized several young Chicagoans as Innovators. Each demonstrated an ongoing commitment to Chicago’s African American community using various platforms, including economic development, the arts, philanthropy and community activism. Featured keynote speaker Tom Wilson, Chairman and CEO of The Allstate Corporation, was introduced by Jasper Robinson, a participant and mentee in the League’s Urban Youth Connection program. Featured at the SUMMIT was Todd Belcore, Executive Director and Co-Founder of Social change, Jahmal Cole, creator of social initiative “My Block, My Hood, My City,” Jessica Disu, Founder of Youth Peace Movement, and Jerald Gary, President and CIO of Community Capital Investment Partners and Chairman of the Chicago Regal Foundation.




JUNE

On June 14th, the Chicago Urban League partnered with the Anti-Defamation League to host a screening of the film *Rosenwald*. This epic film was timely in light of the current racial climate in Chicago and around the country. An in-depth discussion followed the screening. Featured panelists included Sarah Duncan, Co-Director of the Network for College Success; Barbara Taylor Bowman, Co-founder of Erikson Institution; Lonnie Nasatir, Anti-Defamation League; and Shari Runner, President and CEO of the Chicago Urban League. The panel was moderated by WVON's Dometi Pongo and presented in partnership with GCM Grosvenor and Gold Sponsor, BMO Harris.



On May 9th, the League hosted an “On the Table” discussion in partnership with the Chicago Community Trust. CUL President and CEO Shari Runner and Chicago Police Superintendent Eddie Johnson joined 200 other community leaders and residents sharing their perspectives and ideas on how to improve Chicago. “While we may come from different roles and perspectives, our common purpose is the same: to dialogue about how we, individually and collectively, can advance under-resourced and segregated communities to better the lives of African Americans living in Chicago and, therefore, the city as a whole.” said Runner.

HUMAN CAPITAL CENTER



Our department of Human Capital is designed to cultivate the kind of transformational growth and commitment from individuals that will lead to economic self-sufficiency and improved quality of life.

For the second year in a row, there were 50 participants in summer employment who gained work experience.

This FY was the first time 189 youth participated in college tours.



Our Entrepreneurship Center (EC) was founded in 2007 to help African Americans launch, grow, and sustain businesses. Through personalized consulting, educational programs and deal-making assistance, the EC provides entrepreneurs with tools and resources to maximize revenue growth, profitability, job creation and innovation of life.

WORKFORCE DEVELOPMENT CENTER

Our Workforce Development Center programs work to raise African American employment and income levels through job training and placement services, career exposure, career advancement, seminars, coaching and long-term retention strategies.

1. More than 2100 adults and youth were served.
2. 950 individuals received specialized training, one-on-one employment coaching and were placed in jobs.
3. 80% of Workforce participants increased job readiness and digital literacy.
4. 252 youth received hands-on work experience and mentoring.



Our **IMPACT** Leadership Development Program is an intensive, nine-month program that serves a cohort of around 30 African American professionals between the ages of 30-45 years-old. Each program participant is paired with a senior African American leader to help broaden their knowledge base, provide keen insight, and sharpen their perspective to augment their effectiveness as leaders. The program is run in partnership with the University of Chicago Booth School of Business.

HOUSING AND FINANCIAL EMPOWERMENT CENTER

Our Housing and Financial Empowerment Center is a HUD-certified counseling agency as well as a City of Chicago Department of Housing Delegate Agency. We provide low-to-moderate income residents with professional housing counseling assistance through our programs and services.

Our External Affairs Department leads the civic engagement, marketing, and communication efforts of the League.





FISCAL YEAR REVENUE 2016




FISCAL YEAR EXPENSES 2016






